## Consideration of The Monarch Leif I with regard to the handling of justice regarding the ongoing bioweapons attack, 23 August -21.

Referring to law claims few currently see as valid when already within Roman justice there are prohibitions against bioweapons and where one through recognition get many along is, in a crisis situation such as the current one, counterproductive when the goal is prosperity for all and the reduction of suffering.

The current crimes against the previously sleeping Western populations have been made possible by their previous choice to turn a blind eye to the fact that a large part of the world is living in "Hunger Games" conditions and by the fact that very few have dared to support holding the warmongers accountable for war crimes, war propaganda, etc.. For it is not only the media that have censored, if the people themselves had not censored, the western bubble would not exist and everyone would at least know who the ruling villains were but more likely already had dismantled them before they as now is ongoing are trying to murder as many as possible.

## The two distinctly different forms of Authority and The role of Monarchy State Sweden.

"[T]he two distinctly different forms of Authority explain most of it. In the worldview of Understanding Is Right, or thus the Athenian ideals, there Authority is the same as an answer or solution that can be shown to be valid. Propaganda has led us to believe that even in Western so-called civilization this would be authority, but it is not.

The other form of *Authority* is that of the worldview *Hidden Power is Right*, or *Platonism*, or *the Roman perspective* that (beyond the propaganda or bullshit) dominates the current Western world. It is the same as *political or institutional position* deciding what *is Right* or *Wrong* according to the demands of the Ruler. And these decisions, in this worldview, must always be based on maintaining *Authority* as the prevailing political position in order to hide or reject that *Authority* would have anything to do with what can be shown to be valid.

This relationship between the two forms of *Authority* means, for example, that in the *Understanding Is Right* worldview, the best solution may be not to accept suffering. Whereas in *Platonism*, individual suffering is not even considered a problem, as the goal in this worldview is to maintain the political position of *Authority*.

Incidentally, the *Understanding Is Right* worldview does not eliminate a political *elite* or a *State*, as there is a need to organize to make *Understanding Is Right* possible. For example, to issue overriding temporary rules that are valid when it is observed that existing rules create suffering. This is where *Monarchy State Sweden* comes in, as a state that restores the secretly liquidated to foreign business corporations fragmented state *Kingdom of Sweden*. *Monarchy State Sweden* will cease when *Kingdom of Sweden* is restored and handed over to its citizens, who will not be subjects or slaves but under the rights of *Godlanders*. *The original Agreement for the Abolition of Slavery between Great Britain and Sweden, signed in Stockholm on November 6, 1824, literally states "preventing Their Subjects from engaging in any Traffic in Slaves". If someone is a "Subject" under someone/something else, then they are implicitly a slave. Therefore, in this original agreement, only slaves are prohibited from holding slaves in turn. Whether or not the sole sovereign is practicing slavery is therefore entirely up to his or her rectitude. After the sovereign has ceded power to corporations, there is no responsibility and no rectitude.* 

Politicians of the *Hidden Power Is Right* worldview, or *Platonism*, don't look at the map — that's where *Platonism* leads them. They think they can create reality by drawing their own maps. And *Platonism* is that those who don't follow the maps of politicians and other authority figures are crazy. [ ... ]

All of the above needs to be dialogued about. Otherwise, the worldview of bullying and perpetual wars will win. Perhaps then they will win their final victory; the complete destruction of humanity and the planet."
